**Minutes**  
**April 20, 2026**

Mr. Elvezio called the meeting to order at 7:00 p.m.

Mrs. Zafonte moved that the minutes of the regular meeting held on March 19, 2026 be approved as presented. Ms. Kugler-Bode seconded. Carried unanimously.
