

## Commack Public Library Disaster Plan

Objective: Aid the administration and staff of the Commack Public Library in dealing with a disaster

Authority: The Library Director assumes the role of Library Emergency Disaster Coordinator and the Assistant Library Director assumes the role of Assistant Library Emergency Disaster Coordinator. If the Library Director or Assistant Library Director are not in the building, the normal chain of command will determine which staff member assumes this role until the Library Director or Assistant Library Director is onsite. In situations that may be considered disasters, the Board President should be contacted as soon as possible with the remaining board members contacted shortly thereafter.

All staff should understand that in a disaster situation, employees are encouraged to take appropriate action and make appropriate decisions for the safety of the staff and the public.

The Library Emergency coordinator will:

- 1. Take immediate control upon being notified of a disaster
- 2. Make immediate decisions regarding emergency responses
- 3. Order activation of responses
- 4. Notify appropriate outside agencies
- 5. Work with outside agencies during and after the disaster
- 6. Document all activities for multiple purposes

Types of Disasters:

- 1. Weather-Blizzard, flood, hurricane, earthquake, tornado
- 2. Fire or explosion
- 3. Bomb threat
- 4. Loss of utilities
- 5. Noxious smells
- 6. Structural failure
- 7. Motor vehicle accident
- 8. Drug overdose






- 1. Diagram of the Commack Public Library with emergency egresses and exits as well as location of the AED

This plan will be updated in the next several months with additional information concerning each type of disaster.








Lower Level
